EXCERPTS FROM THE MINUTES TAKEN DURING THE 88TH REGULAR SESSION OF THE SANGGUNIANG BAYAN OF IPIL, ZAMBOANGA SIBUGAY HELD AT BARANGAY DOMANDAN ON MARCH 27, 2024 AT 10:00 A.M.

ORDINANCE NO. 03-667-2024

AN ORDINANCE ADOPTING THE OFFICIAL SEAL OF THE SANGGUNIANG BAYAN OF IPIL, PROVINCE OF ZAMBOANGA SIBUGAY, PRESCRIBING THE USE AND IMPOSING PENALTY FOR UNOFFICIAL/UNAUTHORIZED USE THEREOF.

WHEREAS, the Sangguniang Bayan of Ipil recognized the need for the council to have a logo/seal that will represent the principles and aspirations of the body;

WHEREAS, the Sangguniang Bayan is likewise necessary to identify official transactions and documents of the Sanggunian;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF IPIL, PROVINCE OF ZAMBOANGA SIBUGAY, AS FOLLOWS:

SECTION 1. TITLE – This ordinance shall be known as “AN ORDINANCE ADOPTING THE OFFICIAL SEAL OF THE SANGGUNIANG BAYAN OF IPIL, PROVINCE OF ZAMBOANGA SIBUGAY, PRESCRIBING THE USE AND IMPOSING PENALTY FOR UNOFFICIAL/UNAUTHORIZED USE THEREOF”.

SECTION 2. The Sangguniang Bayan of Ipil official Seal has the following symbol:



SYMBOLS AND REPRESENTATIONS

SAGISAG NG REPUBLIKA NG PILIPINAS – represents allegiance to the Republic of the Philippines.

TWENTY-EIGHT STARS – represents the 28 barangays in the municipality.

LAUREL LEAF – symbolizes the commitment of the Sanggunian as mentors and as guiding light for others in the name of Public Service.

BOOK/PAPER AND QUILL PEN – symbolizes duty of the Sanggunian to enact measures for the benefit of the common good.

SCALE OF JUSTICE – the idea of the fair distribution of law, with no influence of bias, privilege, or corruption.

GAVEL – symbolizes of the authority and right to act officially in the capacity of a presiding officer.

YEAR 1949 – year when the Municipality of Ipil was founded.

ROPE – symbolizes of strong bond and unity.

SECTION 3. Custodian of the Original Lay-out of the Seal - The Secretary to the Sangguniang shall have the custody of the original lay-out or draft of the official seal of the Sangguniang Bayan of Ipil. And shall also be responsible in the registration and filing of the Official Seal to the national Historical Commission of the Philippines or any appropriate agencies.

SECTION 4. Purpose of Seal and Authorized Use of Logo/Seal. The official logo/seal of the Sangguniang Bayan OF Ipil shall be for official purposes only. It shall appear in all official documents of the Sangguniang Bayan and in circumstances where the Sanggunian permits the use thereof.

SECTION 5. Unauthorized use of the logo/seal. It shall be unlawful for any person, natural or juridical, to print the official logo/seal of the Sangguniang Bayan of Ipil for purpose of sale, distribution or circulate, manufacture, publish, use, display or offer for sale any document or items, merchandise which simulate the official logo/seal of the Sangguniang Bayan without the express written consent of the Sangguniang Bayan.

Any violation of this provision shall be punishable by an imprisonment of not more than thirty (30) days or a fine of not more than Two Thousand Five Hundred Pesos (P 2,500.00) or both, subject to the discretion of the courts.

SECTION 6. Separability. In the event that a part of this ordinance be declared invalid, the remaining provisions not declared so shall stand effective.


SECTION 7. Repealing Clause. Any ordinance or measure found to be inconsistent with this ordinance shall be deemed repealed.

SECTION 8. Effectivity. This ordinance shall be effective upon its approval.

That this Ordinance was moved by Hon. Farida A. Dangpalan and unanimously seconded.


