ORDINANCE NO. 10-149-2000

AN ORDINANCE TO OFFICIALLY DECLARE OCTOBER 10, 2000 AND EACH ENSUING YEAR THEREAFTER AS LOCAL GOVERNMENT DAY, IN COMMEMORATION OF THE IMPLEMENTATION OF THE LOCAL GOVERNMENT CODE GOVERNING EACH LOCAL GOVERNMENT UNIT, FOR THE MUNICIPALITY OF IPIL, ZAMBOANGA DEL SUR.

WHEREAS, Proclamation No. 63 from the Presidential Office through the DILG requires each municipality to celebrate the anniversary of the Local Government Code implemented into law, between the date of October 1 to 10, each year;

WHEREAS, the LGU of Ipil deems it more opportune to declare this Local Government Day to honor the law which governs each Local Government Unit, on October 10, starting the year 2000;

WHEREAS, further, in order to add greater significance to the commemoration of this important date in Philippine Political History, an hour devoted to the cleaning up of the immediate environs/surroundings of each section in the Local Government Unit of Ipil as well as the Municipal ground is strongly recommended as the more relevant activity on this day, from 4:00 to 5:00 in the afternoon;

NOW THEREFORE, on motion presented by SB Restituto Alejandro Jr., duly seconded by SB Cleopatra Largo, it was;

RESOLVED, as it is hereby resolved, to officially declare October 10, 2000 and each ensuing year thereafter as Local Government Day, in commemoration of the implementation of the Local Government Code governing each Local Government Unit, for the Municipality of Ipil, Zamboanga del Sur.
