ORDINANCE NO. 11-154-2000

AN ORDINANCE CREATING THE POSITION OF PROJECT DEVELOPMENT OFFICER III, SG18, IN THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR (MPDC).

WHEREAS, pursuant to Section 447-(a)-(viii) of RA 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Bayan shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the conduct of programs, projects, services, and activities of the municipal government.

Be it therefore ordained by the Sangguniang Bayan of Ipil in session assembled:

SECTION I. TITLE. This Ordinance shall be known as the Ordinance Creating the Position of Project Development Officer III, SG18, in the Office of the Municipal Planning and Development Coordinator.

SECTION II. QUALIFICATIONS. The Project Development Officer III must have a Bachelor's degree relevant to the job, must have at least two years of relevant experience, eight (8) hours of relevant training, and must possess a Career Service Professional eligibility.

SECTION III. DUTIES AND RESPONSIBILITIES. The PDO III shall be the one to attend to details of work operations, programs and estimates; conduct actual studies to analyze in the construction of projects; follows-up and monitors development projects; process subdivision plans approval; record analysis of complete data necessary for the development of the programs; assists in the evaluation of Zoning applications; conduct information drive on community projects and development; and shall function as such and as may be ordered by the higher authority.

SECTION IV. EFFECTIVITY. This Ordinance shall be filled up as soon as the LGU has the capacity to hire and upon the approval of the Municipal Mayor.

That this Ordinance was moved by the Floor Leader and unanimously seconded.
