ORDINANCE NO. 12-156-2000

AN ORDINANCE CREATING THE POSITION OF PROCESS SERVER, SG5 IN THE OFFICE OF THE MUNICIPAL LEGAL OFFICER.

WHEREAS, pursuant to Section 447-(a)-(viii) of RA 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Bayan shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;

Therefore be it ordained by the Sangguniang Bayan of Ipil in session assembled:

SECTION 1. TITLE. This shall be known as the Ordinance Creating the Position of Process Server, SG5 in the Office of the Municipal Legal Officer.

SECTION 2. QUALIFICATIONS. He/she must be a high school graduate, experience, training, and eligibility are none required per MC 11, s'96-CAT III.

SECTION 3. EFFECTIVITY. This position shall be filled and funded upon the approval of the Municipal Mayor.
