ORDINANCE NO. 12-157-2000

AN ORDINANCE CREATING THE POSITION OF ONE LICENSING OFFICER IV, SG 22 IN THE OFFICE OF THE MUNICIPAL MAYOR.

WHEREAS, pursuant to Section 447-(a)-(viii) of RA 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Bayan shall determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;

Be it therefore ordained by the Sangguniang Bayan of Ipil in session assembled:

SECTION 1. TITLE. This Ordinance shall be known as the Ordinance Creating the Position of Licensing Officer IV, SG22 in the Office of the Municipal Mayor.

SECTION 2. QUALIFICATIONS. To qualify for the position of Licensing Officer IV, one must be a holder of Bachelor's Degree, with three years of relevant experience, with sixteen (16) hours of relevant training, must have Career Service eligibility.

SECTION 3. DUTIES & RESPONSIBILITIES. This shall be provided for by the Office of the Municipal Mayor.


SECTION 4. EFFECTIVITY. This shall take effect upon the approval of the Mayor.


