RESOLUTION NO. 01-167-2011

A RESOLUTION COMMENDING SPO2 ROSEBERT LAYA AND PO3 RIGOR CENABRE OF THE PROVINCIAL INTELLIGENCE DIVISION, ZAMBOANGA SIBUGAY POLICE PROVINCIAL OFFICE FOR A SUCCESSFUL BUY BUST OPERATION LAST JANUARY 14, 2011 AT BARANGAY TENAN, THIS MUNICIPALITY, IN COORDINATION WITH THE ELEMENTS OF IPIL PNP.

WHEREAS, last January 14, 2011 a combined elements from the Ipil Police Station and Provincial Intelligence Division of Zamboanga Sibugay Police Provincial Office led by PI Bonifacio B. Arañaz, Jr. conducted an entrapment operation against an illegal drug pusher;

WHEREAS, the entrapment operation resulted to the apprehension of one Janaide Asmad Ahmad who was engaged in selling dangerous drugs;

WHEREAS, recovered from the possession of the suspect aside from the two (2) sachets of shabu that were sold are the following: four (4) sachets of shabu, three (3) aluminum foils, the P1,000 marked money, one (1) homemade .45 caliber pistol, three (3) magazines with twenty rounds of live ammunitions, military coat and a nokia cellphone;

WHEREAS, the team immediately conducted an inventory of the property seized from the suspect and witnessed by the barangay chairman;


WHEREAS, the PNP will now be filing criminal charges against the suspect Janaide Asmad Ahmad for violation of RA 9165 otherwise known as the Comprehensive Dangerous Act of 2002 and violation of PD 1866 as amended for failure to present papers supporting his possession of firearms;

NOW THEREFORE, on motion presented by the floor leader, unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to commend SPO2 Rosebert Laya and PO3 Rigor Cenabre of the Provincial Intelligence Division, Zamboanga Sibugay Police Provincial Office for a successful buy bust operation last January 14, 2011 at barangay Tenan, this municipality, in coordination with the elements of Ipil PNP.


