WHEREAS, the main street going to the Municipal Hall, Police Station, and Malvar Street was greatly affected by the excavation;


WHEREAS, temporary bridge is being constructed which is very hazardous and causing so much inconvenience to our constituents;


NOW THEREFORE, on motion of SB Valentino C. Inoferio, Sr. and unanimously seconded, it was;
