RESOLUTION NO. 08-066-2016

A RESOLUTION EARNESTLY REQUESTING PRES. RODRIGO R. DUTERTE, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, MALACAÑANG PALACE, MANILA, TO ALLOCATE FUNDS TO FINANCE FOR THE CONSTRUCTION OF THE MUNICIPAL HALL OF IPIL, ZAMBOANGA SIBUGAY IN THE AMOUNT OF FIFTY MILLION PESOS (P50,000,000).

WHEREAS, the municipality's strategic location being situated at the cross roads of the Province of Zamboanga del Sur, Zamboanga del Norte and the City of Zamboanga is what makes it advantageous in its pursuit to become a self-sufficient locality and being the capital town of the newly created province of Zamboanga Sibugay which has now emerged as the new economic, academic and political center of Zamboanga Peninsula;

WHEREAS, the elevation of the Municipality of Ipil as the Provincial Capital town, resulted in the mushrooming of business establishments, unprecedented appreciation of land and properties, jumpstarting of local commerce and influx of people from other nearby municipalities and provinces;

WHEREAS, the Municipality has been longing of the promises of some political candidates that happened to visit our dilapidated Municipal Hall to help and extend financial support for the construction of our new Municipal Hall but it just turned into the lamp light as a promise;

WHEREAS, it is the thrust of the New Administration headed by the First Lady Mayor, Hon. Anamel C. Olegario to help for the progress and development of the Municipality of Ipil more particularly to have a decent and presentable Municipal Hall that would cater for the welfare of the taxpayers and the constituents of Ipil as well;

WHEREAS, it was suggested to tap the national funding due to a meager budget of the Municipality through the help and effort of the Honorable President Rodrigo R. Duterte the construction of a new Municipal Hall will be in place, hence, this resolution;

NOW THEREFORE, on motion of SB Ramses Troy D. Olegario and duly seconded by SB Alberto A. Alcoriza, Jr., it was;

RESOLVED, as it is hereby resolved, to earnestly request Pres. Rodrigo R. Duterte, President of the Republic of the Philippines, Malacañang Palace, Manila, to allocate funds to finance for the construction of the Municipal Hall of Ipil, Zamboanga Sibugay in the amount of Fifty Million Pesos (P50,000,000).
