RESOLUTION NO. 08-070-2016

A RESOLUTION EARNESTLY REQUESTING PRES. RODRIGO R. DUTERTE, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, MALACAÑANG PALACE, MANILA, TO ALLOCATE FUNDS TO FINANCE FOR THE CONCRETING OF VETERANS VILLAGE — TIAYON FARM-TO-MARKET ROAD OF IPIL, ZAMBOANGA SIBUGAY IN THE AMOUNT OF FIFTY MILLION PESOS (P50,000,000).

WHEREAS, presented for consideration is the request for the concreting of barangay roads connecting Barangay Veterans Village to Barangay Tiayon of Ipil;

WHEREAS, due to a meager budget of the Municipality there is a need to look for resources for the concreting of the farm-to-market roads of Barangay Veterans Village to Barangay Tiayon, as it will benefit the barangay constituents and even in the delivery of their agricultural products to the market;

WHEREAS, the august body has been asked for a resolution to support the request of the Honorable Mayor Anamel C. Olegario to look for resources for the progress and development for the Municipality of Ipil to help alleviate the livelihood of the Ipileños;

WHEREAS, it was suggested to tap the national funding due to a meager budget of the Municipality through the help and effort of the Honorable President Rodrigo R. Duterte;

NOW THEREFORE, on motion of SB Ramses Troy D. Olegario and duly seconded by SB Alberto A. Alcoriza, Jr., it was;

RESOLVED, as it is hereby resolved, to earnestly request Pres. Rodrigo R. Duterte, President of the Republic of the Philippines, Malacañang Palace, Manila, to

allocate funds to finance for the concreting of Veterans Village – Tiayon farm-to-market road of Ipil, Zamboanga Sibugay in the amount of Fifty Million Pesos (P50,000,000).
