A RESOLUTION EARNESTLY REQUESTING HON. DULCE ANN K. HOFER, REPRESENTATIVE, 2<sup>ND</sup> DISTRICT OF THE PROVINCE OF ZAMBOANGA SIBUGAY, HOUSE OF CONGRESS, MANILA, TO ALLOCATE FUNDS FOR THE STREET LIGHTS OF THE MUNICIPALITY OF IPIL, ZAMBOANGA SIBUGAY.

WHEREAS, the National Highway and various municipal streets of Ipil has insufficient lighting facilities to serve the fast growing town in terms of its economic and population growth;

WHEREAS, the said road and streets needs more development in order to make it viable for public user especially during night time and to avoid also untoward accident;

WHEREAS, the local government unit of Ipil in its continuing effort to equitably distribute her hard-earned resources to the barangays or sectors of the municipality, it is also taking measures to source out funds to augment in the delivery of its basic services;

WHEREAS, the municipality of Ipil would like to signify our willingness to shoulder the payments of electric bills for the said street lights;

WHEREAS, it is the trust of the new administration headed by the First Lady Mayor, Anamel C. Olegario, and through the congressional funds, the municipality of Ipil is asking that it will be included in priority list of the Hon. Congresswoman Dulce Ann K. Hofer, hence, this resolution;

RESOLVED, to earnestly request Hon. Dulce Ann K. Hofer, Representative, 2<sup>nd</sup> District of the Province of Zamboanga Sibugay, House of Congress, Manila, to allocate funds for the street lights of the municipality of Ipil, Zamboanga Sibugay.
